Supreme Court will review ACA case

The Supreme Court has agreed to review, during its term beginning in October, a federal appeals court decision that held the Affordable Care Act's individual mandate unconstitutional. Twenty states and the District of Columbia petitioned the Supreme Court to quickly review the decision, which sent the case back to the district court in Texas for the judge to take a "careful, granular approach" to determining which of the law's provisions could survive without the mandate.

In January, the American Hospital Association, the Federation of American Hospitals, Catholic Health Association of the United States, the Association of American Medical Colleges, and America's Essential Hospitals filed a [friend-of-the-court brief](#) urging the Supreme Court to review the case this term. NIH: Alcohol-related deaths double over 18 years

Nearly 72,600 Americans died from alcohol-related causes in 2017, double the number in 1999, according to a new [study](#) by the National Institute on Alcohol Abuse and Alcoholism, part of the National Institutes of Health. Death rates increased more for women (85%) than men (35%) over the period. "Taken together, the findings of this study and others suggests that alcohol-related harms are increasing at multiple levels — from ED visits and hospitalizations to deaths," said NIAAA Director George Koob. "We know that the contribution of alcohol often fails to make it onto death certificates. Better surveillance of alcohol involvement in mortality is essential in order to better understand and address the impact of alcohol on public health."
